In a moment I'll update you on what's happening in the Senate. But first a word about our success in the House.

We've been doing something right as a Coalition. There is honest discussion going on among the Members of the Assembly about our bill's intent and effect. And the Leadership is now willing to meet with us.

Last Thursday, Majority Leader Larry Walker committed to meeting with us IF the Minority Leader would participate. Yesterday, Minority leader Bob Irvin agreed to sit down with us and that we should do it at a time when Rep. Walker could participate, as well.

I'm working today to get agreement on when that meeting can happen. It may happen today. I'm open to it if they are.

I'm urging that we continue to be a visible presence at the Capitol. I urge continued constituent contact with your own Members and with the House Leadership, listed below. Just because we're finally getting them to the table does not mean they are ready to negotiate in good faith. Only your continued participation in this effort can ensure that.

We're within one vote of being able to get a Do-Pass recommendation from Senate State and Local Government Operations which is scheduled to meet and act on our bill Thursday.
